

EMERGENCY PROCEDURES

***IN CASE OF EMERGENCY: SOUND AIR HORN THREE (3) CONSECUTIVE BLASTS LASTING 2 SECONDS EACH.**

***REPEAT THIS EVERY 10 SECONDS UNTIL EVERYONE ON THE GROUNDS IS AT THE EMERGENCY SAFETY LOCATION AND EVERYONE IS ACCOUNTED FOR.**

! Each camp will have at least one (1) fire drill during camp to ensure everyone knows where the safe and secure area is located. (This is accordance with the regulations of the State of Oregon)

***EMERGENCY SAFETY LOCATION:**

THE EMERGENCY SAFETY LOCATION IS LOCATED IN THE CENTER OF THE FIELD NORTH OF THE DINING HALL AND WEST OF THE MYRTLE GROVE.

IN CASE OF FIRE:

BEGIN EMERGENCY PROCEDURE. IF FIRE IS NOT EXTINGUISHABLE BY STAFF MEMBERS, CALL 911.

IF IT IS NECESSARY TO EVACUATE THE GROUNDS: USE SANDY CREEK ROAD. IF SANDY CREEK ROAD IS BLOCKED; NOTIFY EMERGENCY PERSONNEL OF NUMBER OF PEOPLE ON THE GROUNDS AND CAMPGROUND LOCATION:

COOS COUNTY (06) TOWNSHIP: 29S; RANGE: 10W SECTION: 02

PERSONAL INJURY:

CAMP MEDICAL PROVIDER AND ONE OTHER PERSON SHALL TAKE INJURED PERSON/S TO SEEK MEDICAL AID OR CALL 911 FOR EMERGENCY SERVICES.

1. Any Emergency treatment and evacuation will require that the Camp Remote Caretaker as well as the *Camp Remote Board of Directors to be notified of the name of the patient, the extent of the injury or illness and the procedures being implemented.
2. If the patient is being transported from the campground the type of transport and the destination of the transport will be reported to the Camp Remote Caretaker as well as the Camp Remote Board of Directors. (*Names and numbers listed below)
3. If someone is being transported the Camp Medical Provider and one other adult will accompany the person being transported.
4. If a county or state agency has been notified or contacted please provide the name of the agency and the contact person and their phone number at those agencies.
